



## JEHEE LIBUNEE 2026 - TERMS AND CONDITIONS

### 1. INTRODUCTION

- 1.1. These Terms govern the "Jehee Libunee 2026" campaign (the "Campaign") carried out by Dhiraagu. These Terms form a part of and are subject to Dhiraagu's General Terms available at [www.dhiraagu.com.mv](http://www.dhiraagu.com.mv) (the "General Terms"). Capitalised terms used but not defined herein shall have the same meaning as in the General Terms. In the event of a conflict between these Terms and the General Terms, these Terms shall prevail to the extent of the inconsistency, in accordance with clause 1.1 of the General Terms.
- 1.2. The Campaign is a football-themed digital engagement promotion accessible exclusively through the Dhiraagu App during the Campaign Period. Eligible Customers may select a national team, earn points and data rewards through real-world match goals and a digital Penalty Showdown game, and compete for prizes, subject to these Terms and the General Terms.
- 1.3. By participating in this Campaign, you confirm that you have read, understood, and agree to be bound by these Terms and the General Terms.
- 1.4. This Campaign may be withdrawn, modified, or extended by Dhiraagu at its discretion in accordance with clause 11.9 of the General Terms.
- 1.5. This promotion is independently organized by Dhiraagu and is not affiliated with, endorsed by or associated with FIFA, the FIFA World Cup™ or any official FIFA entity.

### 2. DEFINITIONS

- 2.1. "Campaign" means the "Jehee Libunee 2026" campaign, being a football-themed digital engagement promotion conducted by Dhiraagu through the Dhiraagu App during the Campaign Period, as further described in these Terms.
- 2.2. "Campaign Period" means the period commencing on 10 June 2026 and ending on 19 July 2026, unless the Campaign is withdrawn, modified, or terminated earlier by Dhiraagu in accordance with these Terms.
- 2.3. "Customer" or "you" means a subscriber of Dhiraagu who holds an active prepaid or postpaid Dhiraagu mobile service number and who participates in or is eligible to participate in this Campaign.
- 2.4. "Data Reward" means 1 GB of free mobile data awarded automatically to a Customer's MSISDN when their selected national team scores a goal in an official match during the Campaign Period, provisioned on the same day as the match (no guaranteed provisioning time)
- 2.5. "Dhiraagu" means Dhivehi Raajjeyge Gulhun Plc (Company Registration No. C-0024/1988), whose registered office is at Dhiraagu Head Office, Ameenee Magu, P.O. Box 2082, Malé, Republic of Maldives.
- 2.6. "Dhiraagu App" means the official Dhiraagu mobile application available for download on iOS and Android platforms.
- 2.7. "Goal Reward" means the combination of a Data Reward (1 GB) and 10 Campaign Points awarded per goal scored by the Customer's selected national team in an official match.
- 2.8. "Penalty Showdown" means the digital penalty shootout mini-game available 24/7 within the Campaign portal, in which the Customer alternates between shooting and defending against an AI opponent over 5 rounds.
- 2.9. "Points" means Campaign points earned by Customers through Goal Rewards and the Penalty Showdown, used to determine rankings, prize eligibility, and winner selection.
- 2.10. "Terms" means these Terms and Conditions applicable to the Campaign.

### 3. ELIGIBILITY

- 3.1. You are eligible for this Campaign if you are an active prepaid or postpaid subscriber of Dhiraagu at the time of participation.
- 3.2. You must hold a valid and active Dhiraagu mobile service number, be in good standing with no outstanding overdue amounts, and be at least eighteen (18) years of age with the legal capacity to contract.
- 3.3. Both prepaid and postpaid Customers are eligible for this Campaign.
- 3.4. Each Customer may participate in the Campaign once per active Dhiraagu mobile service number. For the avoidance of doubt, a

Customer holding multiple active service numbers may participate separately in respect of each such number.

- 3.5. Participation in the Campaign is free of charge. No subscription fee, activation fee, or other charge shall be payable by you to participate in the Campaign.

### 4. PARTICIPATION

- 4.1. To participate in this Campaign, eligible Customers must:
  - a. Log in to the Dhiraagu App during the Campaign Period;
  - b. Navigate to the Jehee Libunee 2026 campaign portal within the Dhiraagu App via the Jehee Libunee banner; and
  - c. Select one of the 32 qualified national teams from a scrollable list displaying each country's flag name.
- 4.2. Team selection is mandatory before any Campaign feature is unlocked. A Customer's selected team is locked to their Campaign profile upon confirmation.
- 4.3. A Customer may change their selected team a maximum of three (3) times during the Campaign Period. A team switch is permitted only when the Customer's currently selected team is officially eliminated from the tournament. Remaining switches are displayed prominently in the Customer's profile. Once all three slots are used, the switch option is locked.
- 4.4. Points already earned by the Customer are retained upon a team switch and continue to contribute to the new team's pool from the moment the switch is confirmed.

### 5. CAMPAIGN MECHANICS

#### 5.1. Goal Rewards:

- 5.1.1. When the Customer's selected national team scores a goal in any official match during the Campaign Period, the Customer automatically receives: (a) 1GB of Free mobile Data provisioned to their MSISDN; and (b) 10 Campaign Points credited to their account.
- 5.1.2. Data Rewards are provisioned automatically on the same day as the match. Dhiraagu does not guarantee provisioning within any specific timeframe. No action is required by the Customer to claim a Data Reward.
- 5.1.3. Own goals do not count as goals for the purposes of Goal Rewards. Goals scored in real-world penalty shootouts do count for the purposes of Goal Rewards.
- 5.1.4. If a goal is cancelled by VAR within 10 Minutes of the trigger, the associated 10 points and Data Reward shall be reversed and a notification sent to the affected Customer.
- 5.1.5. Data Rewards are non-transferable, non-exchangeable, and carry no cash value. Data Rewards are subject to Dhiraagu's applicable service terms and fair usage policies.

#### 5.2. Penalty Showdown

- 5.2.1. The Penalty Showdown is an unlimited replay, head to head digital penalty shootout game available 24/7 throughout the Campaign Period, regardless of whether a real world match is in progress.
- 5.2.2. Each session consists of 5 rounds in which the Customer alternates between (a) shooting, dragging and releasing the ball to score against an AI goalkeeper and (b) defending, dragging goalkeeper gloves to block the AI's shot.
- 5.2.3. Points are awarded as follows: 5 points per goal scored by the Customer against the AI, and 5 Points per AI shot successfully blocked by the Customer.
- 5.2.4. A Customer must complete all 10 attempts (5 shoot +5 defend) for Points to be credited. If the Customer closes the app or leaves the screen mid session, the session is voided and no points are awarded.
- 5.2.5. No Data Reward is associated with the Penalty Showdown Customer will only receive Points only.

#### 5.3. Points and Rankings

- 5.3.1. Points accumulate to both the Customer's individual account and the shared points pool of their selected national team.
- 5.3.2. A public Rankings screen displays all 32 national teams by aggregate fan points, refreshing every 60 seconds. A Customer's personal rank within

- their selected team is visible only to that Customer, no public per player leaderboard is displayed.
- 5.3.3. Public leaderboards display only first name and team flag. No mobile number, full name, or account information is publicly surfaced.
- 6. PRIZES**
- 6.1. The following prizes are available in this Campaign:
- 6.1.1. **Weekly Top Scorer Prize:** Customer with the highest combined points (Goal Rewards + Penalty Showdown) from the No. 1 ranked team at the end of each of the five (5) tournament rounds during the Campaign Period (five (5) winners in total). The winners will receive a MVR 1,000 Sonee Sports voucher.
- 6.1.2. **Top 5 Point Holders — Top 3 Teams:** Top 5 Customers with point holders from each of the top 3 ranked teams at end of the Campaign will get jerseys from Obion (per winner) (Total 15 winners).
- 6.1.3. **Champion Team reward:** All Customers whose active selected team is the No. 1 ranked team (by aggregate Points) at the end of the Campaign Period will receive 1GB free data (validity 1 day).
- 6.1.4. **Grand Prize:** Customer with the highest overall individual points from among Customers who selected the No. 1 ranked team (by aggregate Points) at the end of the Campaign Period will receive a PS5 Slim 1TB + EA FC 26 + Samsung Odyssey G5 27" 165Hz QHD Curved Monitor.
- 6.2. In the event of a points tie for any merit-based prize, the winner shall be selected at random by Dhiraagu among the tied Customers to determine the prize recipient.
- 6.3. All prizes are non-transferable, non-exchangeable, and carry no cash alternative. Dhiraagu reserves the right to substitute any prize with an alternative of equal or greater value if the original prize becomes unavailable.
- 6.4. Prize winners shall be notified by Dhiraagu via the contact details associated with their Dhiraagu account. Winners must respond within seven (7) days of notification, failing which Dhiraagu reserves the right to select an alternative winner.
- 6.5. The results of any prize draw or selection are final and binding. No correspondence shall be entered into regarding the outcome, save in the case of manifest error.
- 7. PERSONAL DATA**
- 7.1. To facilitate the Campaign, Dhiraagu may collect and process certain personal information, including but not limited to your name, contact details, service number, and Campaign participation data.
- 7.2. Dhiraagu may publish the name and/or service number of prize winners for promotional purposes. By participating in the Campaign, you consent to such publication if you are selected as a winner. Save as set out in this clause 7, Dhiraagu shall handle your personal information in accordance with clause 22 of the General Terms.
- 7.3. By participating in the Campaign, you acknowledge and agree that Dhiraagu will collect and process your personal data as described in clause 7.1 for the purpose of administering the Campaign.
- 8. LIMITATION OF LIABILITY**
- 8.1. To the maximum extent permitted by applicable law, Dhiraagu shall not be liable for:
- any failure, interruption, or delay in the Dhiraagu App or Campaign portal that prevents or impairs participation in the Campaign;
  - any failure to provision or deliver a Data Reward or Points due to network issues, system errors, live data feed outages, or circumstances beyond Dhiraagu's reasonable control;
  - any loss, damage, or disappointment suffered by a Customer as a result of participating or failing to participate in the Campaign; and
  - any loss or damage arising from the conduct or outcome of any prize draw or selection process.
- 8.2. Subject to clause 23.1 of the General Terms, the limitations and exclusions of liability set out in clause 23 of the General Terms shall apply to this Campaign. For the avoidance of doubt, Dhiraagu's aggregate liability in connection with this Campaign shall not exceed Fifteen Thousand Maldivian Rufiyaa (MVR 15,000) as set out in clause 23.4 of the General Terms.
- 8.3. You agree to indemnify and hold Dhiraagu harmless from any claim, loss, or liability arising from your participation in this Campaign or your breach of these Terms, to the extent set out in clause 23.5 of the General Terms.
- 8.4. Dhiraagu shall not be liable for any delay or failure in performing its obligations due to circumstances beyond its reasonable control, including but not limited to force majeure events. In the event of a live data feed outage, Goal Rewards and live scores shall be queued and reconciled once the feed is restored; Customers will not be penalised for delayed reconciliation.
- 9. EDGE CASES AND EXCEPTION HANDLING**
- 9.1. **VAR / Disallowed Goals:** If a goal is cancelled by VAR within 10 minutes of the trigger, the associated 10 Points and Data Reward shall be reversed and a notification sent to the affected Customer.
- 9.2. **Own Goals:** Own goals do not count as goals for the Customer's selected team for the purposes of Goal Rewards.
- 9.3. **Real-Match Penalty Shootout Goals:** Goals scored in an official real-world penalty shootout count as goals for the purposes of the 1 GB + 10 Points Goal Reward .
- 9.4. **Team Switch Mid-Match:** Only goals scored while a new team is the Customer's active selection count going forward. Previously earned Points remain in the Customer's total but contribute to the new team pool from the moment of the switch.
- 9.5. **Penalty Showdown Abandonment:** If a Customer closes the app or leaves the screen mid-session, the session is voided and no points are awarded. The Customer must complete all 10 attempts for points to be banked.
- 9.6. **Points Tie:** In the event of a tie on individual points for any merit-based prize, the winner will be selected at random between the tied Customers to determine the prize recipient.
- 9.7. Any use of automated tools, bots, scripts, emulators, exploits, or other methods intended to circumvent normal user interaction or artificially influence leaderboard results is strictly prohibited. Users engaging in such activities will be removed from the leaderboard and may forfeit any prizes, rewards, or account privileges associated with the program.
- 10. GENERAL PROVISIONS**
- 10.1 Dhiraagu reserves the right to amend, suspend, or withdraw this Campaign and these Terms at any time, subject to providing notice in accordance with the General Terms.
- 10.2 These Terms shall be governed by and construed in accordance with the laws of the Republic of Maldives. If any provision of these Terms is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.
- 10.3 You cannot transfer your rights or obligations under these Terms without Dhiraagu's written consent. Dhiraagu may assign its rights and obligations to another provider.
- 10.4 Notices must be in writing and delivered by hand, post, or electronic means. Notices are considered served on the date of delivery, or ten (10) days after posting or, if delivered electronically, on the date the electronic communication was sent.
- 10.5 Any dispute relating to the Campaign or these Terms must be resolved amicably in discussion with Dhiraagu, and if unresolved, shall be referred to the courts of the Republic of Maldives, in accordance with the General Terms.
- 10.6 All decisions of Dhiraagu regarding the Campaign are final, subject to applicable laws of the Republic of Maldives and your statutory rights.
- 10.7 Claims related to the Campaign must be made individually. By participating in the Campaign, you waive the right to participate in any class action or collective proceeding.
- 10.8 Dhiraagu's failure to enforce any right shall not be deemed a waiver of that right.
